Sir/Madam,

This is to inform you that, as per the orders passed by Competent authority (vide its no. Affi.Gen.1/NC-50/V.C.Order/2016-17/778 dated August 08, 2016) and as per the No Objection Certificate issued by the office of the Joint Director of the concerned Region and as per the Government order referred above, the First time Affiliation has been granted to your College to start **B.Com.** programme from the academic year 2016-17 with **intake capacity of 120 students**, in accordance with the provisions of Section 87 of the *Maharashtra Universities (Temporary postponement of elections of members of University authorities and bodies)*, subject to the following terms and conditions :

1. The college concerned should not admit students beyond the intake capacity approved by the University,
2. The college on completion of 5 years have to apply for NAAC accreditation within one year failing which their affiliation will automatically stand cancelled
3. It may be noted that if the Trust is not able to enroll at least 50% students of the approved intake capacity their permission for continuation for the said course is liable to be discontinued by the Joint Director of the concerned Region.

2. The academic, building sufficient to accommodate the faculties, lecture/seminar rooms, library and laboratories with a minimum of 15 sq.ft. per student in lecture/seminar rooms/library and 20 sq.ft. per student in each of the laboratories,
3. The Sanstha shall appoint the number of teaching and non-teaching staff required as per University norms,
4. The adequate civic facilities for essentials like water, -electricity, ventilation, toilets, sewerage etc in conformity with the norms laid down by the Central/State PWD,
5. The library with at least 500 books, or 100 books in different titles on each subject, whichever is more, of the proposed programmes to include both text books and reference books, besides two journals per subject, along with a book bank facility for students belonging to other Schedule Castes, Scheduled Tribes and such other sections as may be specified by the UGC from time to time,
6. Necessary laboratory equipments as prescribed by the University /Statutory/Regulatory body concerned, for each of the higher education programmes,
7. The multi-purpose complex/an auditorium and facilities for sports, canteen, health care, separate rooms and separate hostels for boys and girls as per the local requirements as decided by the University,
8. The appropriate furniture for lecture/seminar rooms, laboratories, library, faculty rooms, rooms for administrative staff including the Principal, multi-purpose complex /auditorium, common rooms and hostels rooms, and other facilities,
9. The College shall satisfy the University that adequate financial provision is available for running the college for at least three years, without any aid from any external source. In particular, it shall produce evidence of creating and maintaining a Corpus Fund permanently in the name of the college by way of irrevocable Government Securities of Rs.35 lakh per programme as you will be starting to offer professional programme, or FDRs for like amounts jointly held by the college and the University for a minimum lock in period of three years. The interest accrued out of it may be utilized by the college with the prior permission of the University for strengthening its infrastructure facilities,
